1. INFORMATION ON DATA PROCESSING

This privacy policy defines the data collected and how it is used, disclosed, transferred and/or stored by the company.

This is an information note in compliance with Articles 13-14 of Regulation (EU) 2016/679 - hereinafter GDPR for those who interact with electronic web services via the address: www.atauce.com

2. PERSONAL DATA PROCESSING METHOD

Any personal data provided or acquired will be processed according to the principles of accuracy, lawfulness, transparency and privacy in accordance with the regulations in force.

The data controller processes users' personal data by adopting the appropriate security measures to prevent unauthorised access, disclosure, modification or destruction of personal data.

Processing is performed with computer and/or telematic tools with organisational methods and a logic strictly in line with the purposes indicated. Personal data collected by this website, either independently or via third parties, includes: cookies, usage data, email and name. Any other personal data collected may be indicated in other sections of this privacy policy or via information texts displayed along with the data collection. Personal data may be entered voluntarily by the user or collected automatically when using this website.

3. COMMUNICATION AND DISCLOSURE OF DATA

In some cases, in addition to the data controller, the following persons or organisations may also have access to the data:

- categories of managers, especially trained for this purpose, involved in the Site's organisation (administrative, commercial, marketing, legal and system administrators);
- external bodies (such as third party technical service providers, host companies, IT companies, communication agencies) also referred to as data processors by the data controller in accordance with Article 28 of the GDPR. It is always possible for the data controller to request the updated list of processors if these have been appointed;



- public or private persons able to access the Data in accordance with legal obligations;
- bodies which perform out ancillary and instrumental tasks relating to the Owner's activity;
- external parties, such as partners involved in organising initiatives and events promoted and/or sponsored by the Data Controller to which Data must be communicated for organisational reasons;

4. DATA VOLUNTARILY PROVIDED BY THE USER

The optional, explicit and voluntary sending of emails and messages via the contact form or the addresses indicated on this Website implies acquisition of the sender's address, necessary for responding to requests, as well as any other Personal Data entered in the email. Users must consent to providing data to register in the data controller's database. This allows the latter to correctly define and implement what it offers its users and any third parties so that they can perform the one-off activity requested. Therefore, failure to provide data prevents registration in the data controller's databases, the performance of any contracts, as well as the performance of this contract and any other possible activity. Therefore, the user's failure to supply certain personal data may prevent this Website from providing its services. The user assumes responsibility for the personal data of third parties published or shared via this Website and guarantees that it is entitled to communicate it or disseminate it, releasing the owner from any liability with regard to third parties.

5. PLACE OF PROCESSING

The data is processed at the data controller's operational headquarters. For further information, please contact the data controller.

6. PROCESSING TIMES

As expressly provided for by art. 5, paragraph 1 (e) of the GDPR, Data is kept for no longer than is necessary for the performance of the service requested by the User or required by the Purposes described herein for which the personal data is processed. In particular:

- Personal data collected for purposes relating to the performance of a contract between the owner and the user will be kept until the performance of this contract is complete;
- Data collected for purposes attributable to the owner's legitimate interest will be kept until that interest has been satisfied. Users may obtain further information about the Owner's legitimate interest in the relevant sections of this document or by contacting the Owner;
- Data collected based on users' consent may be kept until such consent is withdrawn;
- Data collected for tax/administrative requirements will be kept for the time needed to perform the aforementioned purposes in accordance with legal provisions and in all cases for no longer than is required by civil law:
- Data may be stored by the Data Controller for longer periods of time to comply with legal obligations or by order of a public authority;

Users can always request the interruption of processing or the cancellation of data not related to the performance of the contract.



After the retention period, all Personal Data will be deleted. Consequently, at the end of this period, the right of access, the right to erasure, the right to rectification and the right to data portability no longer applies.

7. PURPOSE OF THE DATA PROCESSING

User data is collected to allow the website to provide its services, as well as for the following purposes: contacting users, managing addresses and sending emails, interacting with external platforms and statistics. And, in particular:

- a) to meet any type of obligation required and provided for by laws, rulings and regulations in force relating to commercial uses, in particular tax matters;
- b) to respond to any specific requests sent to the owner by the user via the website and its communication tools (contact forms, etc.);
- c) for sending information relating to the data controller's services following a request for information sent by email, the contact form and any other communication tools;
- d) to send information and promotional and sales offers;
- e) for profiling activities for marketing purposes;
- f) for transferring data to companies and/or third parties with which the data controller works or has agreements, and which may use the data subject's data to send communications and/or information relating to events organised by them or services paid for by them;

The types of personal data used for each purpose are indicated in the specific sections of this document.

For the purposes referred to in point (a), processing is necessary for the performance of a contract to which the data subject is party, for the performance of pre-contractual measures or for the fulfilment of a legal obligation to which the data controller is subject.

For the purposes referred to in points b), c) and d), processing is optional, however, failure to provide one or more items of data will mean that it is not possible to respond to your request for information and use the services offered by the Data Controller.

For the purposes referred to in points (e), (f), (g), processing shall be based on the data subject's freely expressed consent.

8. OTHER INFORMATION ABOUT PROCESSING

8.1 DEFENCE IN LEGAL CASES

The user's personal data may be used for the owner's defence in court or in steps leading to its preparation and against abuses by the user when using the same services or related services. The User declares that he/she understands that the Data Controller may be required to disclose Data at the request of public authorities.

8.2 NATURE OF THE DATA PROCESSED AND CONSEQUENCES OF ANY REFUSAL



The provision of browsing data by Users for the afore-mentioned purposes depends on the degree of confidentiality the User has activated or deactivated in his/her browser. In some cases, deactivation may affect browsing on this Website. For some of this Website's modules, the browsing data and/or the use of technical cookies is mandatory for the Website's proper functioning. In all cases, certain personal data is required for the structure of the Website and its procedures. In particular, by way of example:

- in all cases, the minimum data required is mandatory for sending messages via the contact form;

Otherwise, the procedure cannot be completed. Any request for other optional data will be preceded by a specific approval tick. The provision of all other data is optional, depending on the type of information the user wishes to provide to the Website.

8.3 ENFORCEMENT OF THE INTERESTED PARTY'S RIGHTS

The interested party will have the right to exercise the options provided for in Articles 7.15-22 of Regulation 679/2016.

In particular, he/she has the right to withdraw his/her consent at any time and, upon simple request to the Data Controller, he/she may request access to his/her Personal Data, receive the Personal Data supplied to the Data Controller and, if possible, transfer it to another Data Controller without hindrance (so-called portability), benefit from updating, limitation of processing, rectification of data and cancellation of any data processed in breach of the legislation in force. He/she has the right, on legitimate grounds, to object to the processing of his/her personal data and to processing for the purpose of sending advertising material, direct sales and market research. You also have the right to file a complaint with the privacy guarantor as the supervisory authority for personal data protection. Cookies are small text files used by websites to improve the user's browsing experience and are sent to the user's browser where they are stored before being used again by the same Website for subsequent visits.

Cookies have different functions. There are cookies that aim to improve functioning and browsing on this website (so-called technical cookies). There are also Cookies that are used to monitor users as they browse, recording information that show their centres of interest, analysing what they read, their leisure activities, in order to personalise advertising presented to them when they open an email, consult social media or any other Web pages (so-called profiling cookies). Cookies are used to personalise content, provide social media features and analyse traffic.

In his/her browser, the user can set privacy preferences in order not to store cookies, delete them after each visit or when the browser is shut down, or only accept cookies from www.atauce.com and not from third parties.

Depending on how long the cookies remain on the browser, they are divided up into:

Session cookies: temporary cookies that remain on the device until the user leaves the site.

Persistent cookies: cookies that remain on the device for a longer period of time until they are deleted.

This site uses different types of cookies

9.1 TECHNICAL COOKIES

Technical cookies are those that do not require the user's consent. These cookies are used solely to send a communication over an electronic communication network or if explicitly requested by an IT service provider. On this Website, technical cookies are used to store the user's decision regarding the use of cookies on the Website. The retention period for technical cookies is the duration of the browsing session on the Website.

9.2 THIRD PARTY COOKIES

These cookies are used to collect information anonymously about how users browse the site, such as: pages consulted, time spent, origin of traffic, geographical origin, age, gender and centres of interest for statistical and marketing purposes. These cookies are sent from third party domains external to the Website.

9.3 STATISTICAL COOKIES

Google Analytics

These cookies are used to collect information, in aggregate form, about the number of users and how they browse this Website. This Website uses Google Analytics offered by Google with an anonymised IP



address, with associated cookies that come from third parties, for statistical tracking of website activities. Google Analytics uses cookies that do not store any personal data.

With the Google Analytics dashboard, it is possible to see whether visits were made by new or repeat visitors by checking how pages are browsed (entry, exit links, movements between pages, time spent, geographical origin, etc.).

The retention period for analytical cookies is two years.

9.4 SOCIAL MEDIA BUTTONS AND WIDGETS

To ensure that the content of a site can be shared on social media by visitors to the site, it is possible to integrate tools (widgets) provided by social media firms. These tools (usually blocks of code inserted into the host site's pages) can collect third-party cookies installed by social media.

The website does not share any data with these widgets and does not have access to data that is collected and processed independently by social media platform operators.

9.5 DELETE OR DISABLE COOKIES

With the exception of technical cookies strictly necessary for standard browsing, it is up to the User to decide what data to make available when browsing the site, after reading the summary information provided in the appropriate banner, and whether or not to use the services of third parties that require the installation of cookies. The User can avoid installing Cookies by keeping the banner open (not closing it by clicking on the "OK" button) and unchecking the box for some or all of the categories of cookies used by the Website, as well as by using the specific functions available on the browser.

Users can manage their cookie preferences directly in their browser and prevent third parties from installing them.

Users must note that disabling all Cookies may compromise the functioning of this Website.

Each browser has different procedures for managing settings.

System log and maintenance

ENFORCEMENT OF THE INTERESTED PARTY'S RIGHTS

In accordance with art. 15-22 of European Regulation No. 679/2016, the interested party has the right to obtain confirmation of the existence or not of his/her personal data, even if not it is not yet recorded, and its communication in an intelligible form.

Therefore, the interested party has the right to obtain information concerning:

- the origin of personal data;
- the purpose and methods of processing;
- the logic used in the event of processing with electronic tools:
- identification data for the Data Controller and Data Processors;
- the subjects or categories of subjects to which Personal Data may be communicated or which may encounter it in their capacity as representatives appointed within the State's territory, managers or agents.

The interested party has the right to obtain:

- the updating, rectification or, where appropriate, the integration of Data;
- the cancellation, transformation into an anonymous format or blocking of data processed in violation of the law, including that which does not need to be retained with regard to the purposes for which the data was collected or subsequently processed.

The interested party has the right to object in full or in part:

- the processing of his/her personal data for legitimate reasons, even if these are relevant with regard to the purpose of the collection;
- the processing of his/her personal data for sending advertising material, for direct sales or for market research or commercial communication.
